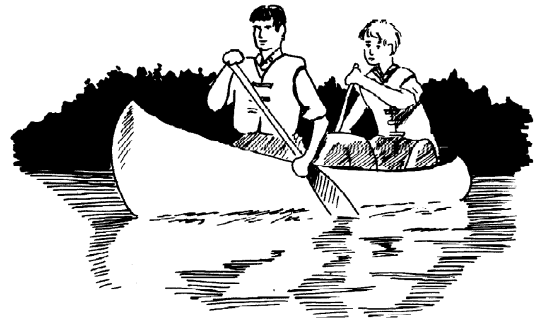


Activity: FORMICAT (FORty MIlle CAnoe Trip)

Details: We're going to recreate the first part of our highly successful adventure of 2012, the "HUMICAT" (Hundred Mile Canoe Trip)...the only exception is that we're only doing the first part this time, four days and around 42 miles. We'll start near Trego, Wisconsin, and paddle the Namekagon River until it hits the St. Croix River and take that to the town of Danbury. The costs are kept very low on this trip thanks to us being able to borrow canoes from L.E. Phillips Scout Reservation. This \$40 should be the only money needed by Scouts, including a celebratory dinner at Pizza Hut Sunday, probably after we get the trailer unloaded and everything packed away. Even that is a little conservative – if we have money left after all is said and done, we can return it to Scout accounts.
